Taskforce to oversee Presbytery's five-year assessment

Presbytery Committee Corner: Coordinating and Planning Commission (CPC) his month, we members and their used res

interviewed Rev. Trinity Whitley, outgoing Presbytery Moderator and incoming Coordinating and Planning Commission (CPC) chair.

What is the CPC's purpose?

The CPC provides for strategic planning. coordinates the work of the presbytery, and serves as a commission of presbytery to address matters needing immediate attention between presbytery meetings. Since the CPC's membership includes the past Presbytery moderator (chair), current moderator, vice-moderator, and all presbytery committee chairs, the CPC are knowledgeable about what is going on within the presbytery and can make decisions on the presbytery's behalf between meetings.

Although the CPC can vote on important issues between presbytery meetings, it tries to send all important issues to the presbytery to vote on. The presbytery can overrule any decision that the CPC makes between presbytery meetings.

The CPC also oversees the planning and docket of presbytery meetings and nominates to presbytery Committee on Representation and Committee on Nominations members and their respective chairs and vice-chairs.

What is the new initiative that the CPC is undertaking this year?

One of the CPC's purposes is to guide the presbytery. To that end, the CPC voted to enter in the Holy Cow! process as a presbytery. Holy Cow! is a successful evidence-based discernment process for congregations. The CPC also voted on who will serve on the task force that will guide the process for the presbytery. The task force consists of a group of folks (laypersons, clergy, and elders) across the presbytery who are knowledgeable about the presbytery's work.

The task force will use a process to discern who we are, where we've been, and where we want to go as a presbytery. The task force will survey people across the presbytery (from all congregations and districts) who are involved in the presbytery's work.

What triggered the CPC to implement the Holy Cow! process within the Presbytery?

The presbytery staff has expressed their concern to us about the need for some presbytery-wide planning and direction given the budget shortfall for the two years. The presbytery has used reserves to balance the budget, and this approach to balancing the budget is not sustainable.

The CPC recognizes that our ministry priorities have changed and that the current budget is based on past priorities. The conversations generated through the Holy Cow! process will give us guidance and wisdom as to what our current ministry priorities are and how to raise money to fund those priorities.

What is the timeframe for completing the Holy Cow! process?

The CPC has asked the task force to present its findings and recommendations to the presbytery at its October meeting.

What is your goal as incoming moderator of the CPC?

Serving as presbytery moderator is a three-year process: You serve first as vice-moderator, then as moderator, and finally as past moderator. My final gift to the presbytery in this position is to actively listen for ways in which the Spirit is calling our committees to connect with one another, to help each other, and to work together.

ESG (Environmental, Social and Governance) Investing is a good thing

omalia's devastating drought is ground zero in the global climate emergency. The UN says that every single minute, another malnourished child is being admitted to a hospital. These children haven't eaten properly for weeks. They need urgent treatment -but in Somalia, hospitals are overwhelmed, and 7 million people are in immediate danger of starving to death.

The roster of climaterelated suffering is long, painful and widespread, and is happening now. It isn't a future event. It is here and causing misery and deaths for our brothers and sisters, near and far. It isn't waiting for our government to debate the issue, for every denialist to face reality or for the Presbyterian church to get rid of its fossil fuel holdings.

And, the sad fact is that, after years of educating the public about the dangers of our warming world, a new <u>United Nations report</u> found that the Earth is on track to blow past a safe temperature threshold, and the suffering will increase.

My message to you is that you need to be informed and understand that those benefiting from the use of fossil fuels are hard at work and have been for decades in fighting regulations and programs that reduce our dependency on fossil fuels. The most recent example is opposition to ESG (Environmental, Social and Governance) investing.

ESG investing involves using a set of criteria that address environmental, social and governance issues to screen potential investments. They are voluntary and aspirational.

Environmental criteria consider how a company safeguards the environment, including addressing climate change. Social criteria examine how it manages relationships with employees, suppliers, customers, and the communities where it operates. Governance deals with a company's leadership, executive pay, audits, internal controls and shareholder rights.

Opposition to ESG investing is the latest example of a wellcoordinated opposition by the fossil fuel industry to interfere with the shift to renewable energy.

The fact is that ESG popularity is booming

and is now attracting more investment than any other area in the world. Our Presbyterian <u>Committee on Mission</u> <u>Responsibility through</u> <u>Investments</u> supports and promotes investments based on our faith teachings which are consistent with ESG principles.

I encourage you to learn more about ESG investing and the orchestrated campaign to stop it in Florida. Here are a couple resources on ESG basics and a third one on the opposition:

- <u>What Is</u> <u>Environmental</u>, <u>Social</u>, and <u>Governance (ESG)</u> <u>Investing?</u>
- <u>Investable World</u> <u>The ESG Investing</u> <u>Backlash</u>

Progress is being made in shifting the world to renewable energy, but each new opposition campaign delays the shift, means more people suffer, and threatens our collective welfare and God's creation. Learn all you can about this and think about how Jesus would respond. Just like I thought Jesus would drive an EV. I think he would also like ESG investing.
