GA applicants, presbytery vice moderator needed

he Ministry of Representation presently has many irons in the fire. First, MR needs to nominate and the Presbytery elect one teaching elder commissioner, one ruling elder commissioner, plus one alternate for each, and one Young Adult Advisory Delegate (YAAD) to the 227th General Assembly. The GA will be held via Zoom June 22 - 24, 2026, and in person in Milwaukee, WI, June 27 – July 2, 2026.

Guidelines with an application form have been sent to each church in the Presbytery's pastor and clerk of session, as well as posted in the Presbytery's weekly e-newsletter. The deadline for applications is July 13,2025.

Second, we need a Presbytery Vice Moderator, class 2026. This position is a three-year leadership commitment at Presbytery. You'll serve one year as Presbytery Vice Moderator, one year as Presbytery Moderator, and one year as Moderator of the Ministry Coordinating Council. The selected individual will attend a moderator training class presented by the PC (USA).

Third and fourth, a candidate for class 2027 is needed to serve on the Ministry of New Congregation Formation, and we need an alternate elder commissioner for the Synod. If you are interested or need more information, please contact me by phone at 850-832-6577 or email kangas 265@gmail.com.

Strategic Plan ongoing progress continues

he Implementation Taskforce was established with clear direction from the Presbytery of Florida, through the vision "Be a Presbytery of Strong, Healthy, Energetic Congregations Advancing the Ministries of Jesus Christ" and mission "Provide Guidance. Training, and Assistance to Our Congregations." Using the details found in the Presbytery-approved Strategic Plan, the taskforce continues working to move the presbytery forward in meeting these challenges set through continuous progress of monitoring, assisting where challenges arise, and listening to members of the presbytery. Members of the Taskforce include Rev. Mark Broadhead (Retired), Elder Rick Clubb (Gulf Beach, Panama City Beach), Elder Tim Crawford (First, Crestview) Elder Emily Moss (First, Lynn Haven), Rev. Erin Rugh (Faith, Tallahassee) and Elder Karen Weaver (First, Monticello).

Earlier this year, the presbytery declared the first-year goal of "Move from Static to Ecstatic" was successfully completed, as all ministries are functioning as designed by the Strategic Plan. Certainly, this does not mean everything is perfected and meets all our needs;

improvement continues and on a regular basis. An example of this was displayed during our Spring Presbytery Meeting, held in May, when the name of the Ministry of Congregational Health was approved to update their name to the Ministry of Congregational and Pastoral Health. This change better reflects the critical ministry's duties and work of supporting the Presbytery's vision and mission.

With the first-year goal of the Strategic Plan's five-year reorganization effort complete, we are now moving toward completing our years two and three goal titled "A New Culture in the Presbytery is Afoot", where our ministries are engaged with three efforts: 1. To identify members of our presbytery to be resources for interacting with local churches to help "Meet Individual Congregation's Needs." 2. Enhance our communications to "Convey the New Culture Within the Presbytery, and 3. "Advertise What Our Presbytery Now Gives to You."

This phase is the key element to our Strategic Plan and requires everyone to be involved for the plan to be successful. This involvement includes everyone available to work with and in our ministries. If you are looking for a place to use your talents, contact the presbytery office or me. Should you be asked to join a ministry or be part of a team, say yes! Other things you can do: Continue to support your congregation's financial pledge to the presbytery; advocate for the presbytery's vision and mission, and, most importantly, include our presbytery in your regular prayers.

As we continue our presbytery's journey, challenges to fulfilling the Strategic Plan goals will always be found, but the work and efforts of our ministries and the **Implementation** Taskforce will endure by relying on the strength that comes from you and our unity as one church and our shared purpose. It's Per Capita, not a "head tax"

he work and ministries of the presbytery, Synod, and General Assembly are financially supported by what congregations contribute through what is known as Per Capita (Latin = for each head). How does this work?

Through much of the presbytery's history, the Per Capita amount asked for was determined by what the General Assembly and the Synod of South Atlantic required per member, plus a relatively small amount asked to help maintain the "business side" of the presbytery.

A second line item called Unified Giving was used for supporting the missions and ministries of the presbytery. Some congregations gave generously to the Unified Giving, others gave what they felt they could afford, a few gave nothing.

About eight years ago, the presbytery budget was realigned. The two separate lines – Per Capita are asked, but not

and Unified Giving – were combined to form the Shared Support line. This was designed to ask all congregations to share equally, per member, in meeting the requirements of General Assembly, the Synod, and support for ongoing ministry.

Being Presbyterian means we are part of a connectional denomination. General Assembly, Synod, and presbytery needs were all taken into consideration to determine the amount of money needed to meet these obligations. This amount was then divided by the total membership of our congregations in the presbytery. Each congregation was then sent a request for their share to support the mission and ministry of the presbytery and denomination.

Something many do not know: The presbytery is *required* to pay the General Assembly and the Synod their portions of the Per Capita. Congregations are asked, but not required, to give toward the per capita amounts. What congregations give helps offset those required of the presbytery.

This year, 15% of the per member amount is sent to the General Assembly and the Synod, leaving the remainder for our use. This means that whatever is not covered by congregational giving reduces the amount available for the work, ministries, and mission of the presbytery.

So, where do things stand financially? The bare bones budget for 2025 is \$339,144. Church pledges for 2025 total \$306,775. Amount required by General Assembly and the Synod: \$50,871. Because not all congregations have made a pledge yet, and because some have pledged less than asked for, there is a \$32,369 shortfall.

The Shared Support line (per capita) is not a head tax (to which I have heard it erroneously referred far too many times). Rather, it is an amount determined to encourage us all to give our share to God's ministry as it happens in and through the Presbytery of Florida.

For the presbytery, the per capita remittance is a requirement. For congregations and individuals, it is an optional privilege to give to the work of God.

I encourage you to give joyfully to the work of our Lord as we continue to move into the future God has in store.

More on the importance of trees...

don't like sharing distressing information with you. But the more information you have about what is happening to creation, the better you are able to make decisions and to understand what is happening to it.

Last month, I wrote about how important trees are to human survival and that one of their important functions is to remove carbon dioxide, a greenhouse gas from the atmosphere. Here is more on why that is so important and how it might be in jeopardy

It begins with a troubling finding that was highlighted in a Washington Post article in April. Carbon dioxide, a greenhouse gas, accumulated in 2024 at the fastest rate in recorded history. It was a 30 percent increase, resulting in the highest level of accumulation in the atmosphere in at least 3 million years. Why did this happen? Are we burning more fossil fuels or is something else going on?

As an aside, 3 million years ago, during the Pliocene epoch, the Earth was significantly warmer, with the global average temperatures around 2-3 degrees centigrade warmer than today, and sea levels were at least 82 feet higher. The Arctic was ice-free and green. And, yes, most of Florida was underwater.

And if you are wondering why, if carbon dioxide levels are as high as they were 3 million years ago, the temperature and sea level are not also higher. The short answer is "thermal inertia". Oceans absorb a large amount of the excess heat from rising CO2 levels, delaying the immediate warming of the atmosphere.

But back to the main point: Most of the atmospheric carbon dioxide comes from our burning of fossil fuels. But a recent study suggests that the 2024 dramatic increase in carbon dioxide may be the result of the deterioration of rainforests and other land

ecosystems because of soaring temperatures. If this is proven to be correct, this is scary. Oceans and trees take up much of carbon dioxide that we emit. But last year, with the extreme droughts and raging wildfires, huge amounts of carbon were released from forests, effectively cancelling the amount that oceans and trees absorb. Forests and other ecosystems take up about 30 percent of the carbon emitted by humans.

The significant point here is that climate change may be having a weakening impact on natural systems that take up carbon dioxide. Trees are important carbon sinks, sucking up billions of tons of carbon through photosynthesis, and it is locked away in wood or buried in the soil. We depend on forests to buffer our emissions, but they are being hurt by our warming temperatures and resulting droughts and wildfires.

We simply cannot afford, as proposed recently, to so dramatically increase the amount of timbering in our national forests, because these trees once removed will no longer take up carbon.

Just remember that last time it was this warm, Florida was underwater. For now, thank God for creating the oceans and all that they do for us.
